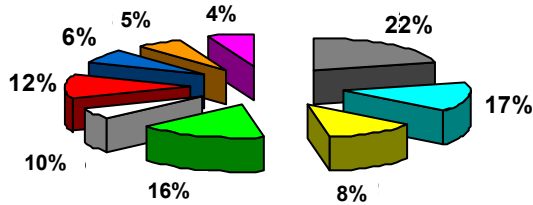
**Pledge Goal: \$300,000**
