INFORMATION SHEET FOR LB 158

Proposed legislative bill: LB 158 Eliminate two year waiting period and restore voting rights immediately upon completion of felony sentence, including parole or probation.

History: Nebraska adopted lifetime disenfranchisement (deprived of the right to vote) in 1875 during the Reconstruction era after the Civil War. In 2005 the legislature established the current two year waiting period. In 2017 the legislature passed a bill to eliminate the waiting period, but it was vetoed by Gov. Pete Ricketts. A similar bill was introduced in 2018 and in 2020, but neither advanced from committee to be voted on by the legislature. LB 158 was introduced in January 2021 and could be considered by the legislature in the session starting January 5, 2022.

Why the Side with Love Social Justice Team supports LB 158:

The two year waiting period restricts a person's constitutional right with no meaningful policy justification and is taxation without representation. Punishing a person by restricting their constitutional right to vote for a period beyond their sentence is a holdover from the days of blocking people of color from voting and should be eliminated. In 2020, an estimated 25percent of the votes disenfranchised by this law in Nebraska were black, while black individuals make up only 5.2 percent of our state's population, according to Shayna Bartow in her testimony at the Government Hearing. When a person has completed the sentence imposed by the court for commission of a felony, restoring to that person the right to vote will encourage them to play a role in their community, to be engaged.
